Applicability: KAUST Scale-X applicants, participants, former applicants, and former participants

This privacy notice ("Notice") applies to current and former applicants and participants in the KAUST Scale-X soft landing program. The purpose of this Notice is to inform you of how KAUST processes your Personal Data. This Notice does not form part of any contract.

For the purpose of applicable data protection legislation, the entity which is responsible for your Personal Data is King Abdullah University of Science and Technology, Thuwal 23955-6900, Kingdom of Saudi Arabia ("KAUST", "we", "us", "our").

This Notice replaces and supersedes any previous notices addressing the same or similar issues, whether formal or informal. KAUST reserves the right to alter, amend, or replace this Notice in whole or in part. The latest version of this Notice can be found here. #### 1. What Personal Data does KAUST Scale-X collect?

Depending on your level of participation in the program, the following types of Personal Data may be collected:

- Personal details such as name, date of birth, gender, nationality, country and city of residence
- Contact information such as email, phone number, LinkedIn page, and WhatsApp number
- Professional information such as previous educational and professional experiences, job title, organization or startup affiliation, business email address, CV, and English proficiency
- Information about your emergency contacts
- Passport number and expiry, Saudi visa status, copy of Saudi visa, special visa requests or notes
- Signed agreements
- Information related to flight or accommodation bookings or other program logistics (i.e., workspace allocation, provision of food or transport)
- Photos and videos
- Communications
- Information voluntarily shared by participants

#### 2. What sensitive Personal Data is being collected?

We may also collect, store and use the following sensitive personal information, when applicable:

- Information about your religion, limited to whether you are Muslim / Non-Muslim
- Dietary restrictions
- Accessibility needs

#### 3. Where do we get your Personal Data?

Most Personal Data is collected from the information you enter into the application, and, if applicable, information you provide in the acceptance form and include in communications.

We may also obtain information about you from individuals who refer you to our program or that you publish online, for example, in your LinkedIn profile or on social media accounts. We may also obtain publicly available information about you from online resources.

KAUST may receive information about you that you provide to our KAUST Scale-X collaborators, including third party evaluators, to make a decision on enrollment and to support the operation and administration of the program.

KAUST may receive information about you from our third party service providers such as confirmed travel and accommodation bookings and confirmations related to special meals, accessibility requests, or other special requests.

For participants carrying a visa issued by KAUST, KAUST is able to access visa details on the Ministry of Foreign Affairs' portal. For participants requesting a visa extension, KAUST has access to relevant information (nationality, passport details, border entry number, and visa expiry date) about you on the Ministry of Interior portal related to the visa extension application.

#### 4. Why do we collect your Personal Data?

KAUST processes your Personal Data to make a decision on your application to the KAUST Scale-X soft landing program and to administer the program, including to support with the logistics of visiting and working in Saudi Arabia. Your Personal Data collected by KAUST will not be processed later in a manner inconsistent with this purpose, except as provided or required by law.

## 5. Do I need to provide all of the information requested?

Optional content is marked on the application and acceptance forms.

#### 6. Why are we able to process your Personal Data?

We may process your Personal Data with your consent.

## 7. Does the processing involve profiling and/or any automated decision-making?

No, KAUST does not rely on any automated decision-making or conduct any profiling in this process.

# 8. Who do we share your Personal Data with, and how do they process the Personal Data?

Within KAUST, we may share relevant information with specific individuals to review and evaluate your application, to decide upon a request or issue, or to provide you with support as a participant in the program.
